Terms & Conditions

1. This agreement constitutes an order for wedding portraiture services, including the taking of wedding pictures as agreed to by both parties: The Photographer and Contracting Party (Client). Unless otherwise specified, it is understood that any and all rights to proofs, final or sample prints, thereof shall remain the property of the Studio and may be used for advertising, display or any other purpose thought proper by the Studio.
2. If Photographer cannot perform this Agreement in whole or in part due to a fire or other casualty, acts of God or nature or terror, or other cause beyond the control of the parties or due to Photographer's illness or injury, then Studio will return all fees to the Client(s) but shall have no further liability with respect to this Agreement. This limitation on liability shall also apply in the event that photographic materials or digital media are damaged in processing, lost through camera malfunction, lost in the mail, or otherwise lost or damaged without fault on the part of Photographer. Client(s) agree that an entire wedding cannot be replicated, re-enacted or repeated for the purpose of a re shoot and limits Studio's liability to the amount paid under this contract.
3. It is understood and agreed that no other photographer will be allowed to photograph or take pictures at the wedding while the Photographer is working.
4. A Booking Fee is due at the on signing of this agreement. The Photographer will reserve the time agreed upon and will not make another reservation for the specific time frame. For this reason, the Booking Fee is non-refundable even if the date is changed or if the wedding becomes cancelled for any reason.
5. Further payment of all necessary expenses (unless otherwise specified) such as parking, travel (if more than 15 miles), taxi, air fare, hotel charges, etc., to be paid at least two weeks before the event. No photography will take place and no rights are granted until timely payment is made in full. Late payment fees may apply.
6. If the photographer is to stay until after the meal then a meal and refreshments will be provide for him (and his assistant).
7. The Client may cancel this contract 6 months prior to the wedding with only the loss of the Booking Fee. Cancellation between 6 months and 2 months then 50% of the total fees become due. Cancellation with less than 3 months to the wedding then 75% of the total fees become due. Should the photographer be able to fill this date with another wedding, then these cancellation fees will be waived.
